The activities listed in the service groups are only a “selection” of possible contents of the total services. This does not exclude that further services may be possible, if agreed, which may be part of the total scope of the position. Some services may be excluded if not required. It must be noted that an individual services group will not be created, when a service is already covered by an appropriate service group. In general, the individual services may be invoiced consecutively as well as sever

al times per day, unless otherwise agreed.

If two service personnel are required for one person in need of care in reasonable individual cases, the following must be carried out: The care insurance reviews the necessity after receipt of the reasonable information from the care service, possibly by consulting the MDK. Should the service of two care personnel be approved, the service groups (LK 1 – 9) as well as the service flat rate (LK 17) will be charge according to the number of caregivers assigned. The service proof must be marked accordingly.

The amount of the additional investment costs to be invoiced by the nursing service amounts on average to 2.5 percent of the services provided. These are not covered by the care funds, they are to be paid privately. If the financial conditions are met and the nursing service has concluded an agreement with the State of Berlin, the social welfare offices will cover the costs.

In order for each person in need of care to be able to make their care even more individual, nursing services must offer time-dependent assistance in addition to the existing service groups. These include not only basic care and domestic services but also general care services. The costs of these services are negotiated individually with the care funds and the state of Berlin.
